COUNCIL ON HIGHER EDUCATION: DR. K. NAIDOO

- Role clarification; Education is a national competence, housed under Department of Higher Education and Training (DHET) as per National Qualifications Framework (NQF) Act 67, 2008
- Nursing is no exception but Nursing Education Institutions (NEIS) have also to meet South African Nursing Council (SANC) professional requirements as a regulatory body
- Acceleration of articulation process for legacy programme is very crucial to be aligned with Higher Education Qualifications sub-Framework (HEQSF)
- Last date of offering legacy programmes if not aligned with HEQSF will cease to exist

CHE

- ► Alarms; Public Nursing Colleges as lag behind in submitting their new programmes and impact is very in early 2020's
- Minister of DHET has been advised about the last date of legacy programmes in general by 31/12/2016 and awaiting his response.
- ► Evaluation is based on nine (9) criteria and emphasis on criteria 1-3 and must be integrated, coherent whole & scientific
- SANC full endorsement letter is a pre-requisite for programme evaluation
- Three committees before accreditation is granted i.e. evaluation; accreditation and quality assurance

SOUTH AFRICAN NURSING COUNCIL: MRS T. MANGANYE

- SANC as a regulatory body governed by Nursing Act, 33 of 2008, which is a supreme law of a nursing profession (protection of the public through quality nursing care service delivery
- SANC has adopted a facilitative developmental approach in reaching to nurses and nursing profession
- Milestones through various committees (impairment, education, laws, practice and standards)
- ► Reforms that are palpable (outreach programmes, extension of payment annual licence to practice, improved turn around time at SANC offices, feasibility studies decentralisation & survey on DD's)
